The 1998 Esso Longford (Australian) gas explosion was a catastrophic industrial accident, killing two workers and injuring

Gas supplies to the state of Victoria were severely affected for two weeks. The fire at the plant was not extinguished until two days later. The sudden crisis was devastating to Victoria's economy, crippling industry and the commercial sector (in particular, the hospitality industry which relied on natural gas for cooking).

Loss to industry during the crisis was estimated at around AUD\$1.3 billion.

"Sharjah Police confirmed the fire started at 2.30am at the Emirates Oil Refining Company (ERCO) and was contained at 11.30am. Police rushed to isolate the premises and remove nearby workers, boats and machinery in order to limit the damage." (Ahmed Ramzan/Gulf News)
